### HISTORICAL NOTE

The 1965 Legislature created a State Advisory Committee on Aging and, in 1971, the name was changed to the Nebraska Commission on Aging. That name was changed again to the Nebraska Department on Aging in 1982.

The department works to promote a life of dignity and opportunity for older Nebraskans. It supports programs and services that promote suitable housing and choice in living arrangements, adequate retirement income, a choice between retirement and continued employment, affordable transportation, comprehensive educational systems, and improved physical and mental health care.

The 1987 Legislature gave the Department on Aging authority to certify care management units., and in 1991 created the office of the state long-term care ombudsman programs, which must comply with the department's rules and regulations in order to maintain designation.

The department sets policy and supervises legislative, public information and education activities; prepares the Nebraska State Plan on Aging; prepares an annual budget; and monitors statewide program fiscal operations.

LB1044, 1996, eliminated the Department on Aging, and merged it into the Nebraska Department of Health and Human Services.
