HISTORICAL NOTE

Johnson County, Nebraska, was named in honor of Richard Mentor Johnson, 1751-1850, a well known army officer in the War of 1812 and Vice President of the United States, 1837-1841. This county was created by an act of the first Territorial Legislature on March 2, 1855. However, it was not organized as a county until February 10, 1857. A number of additional Legislative acts in 1857 separated Johnson County from Nemaha County, defined the county's boundaries and in addition Tecumseh, located at the intersection of the Nebraska City-Marysville and Brownville-Fort Kearny Trails, was designated as the county seat. The first county officers who administered its early affairs were appointed by then Governor Izard and served until the first official election in August of 1857.

SCOPE AND CONTENT NOTE

NOTE: Due to the way the collection was organized in 1973 at the time of filming parts of SG1, SG2 & SG6, this inventory may seem confusing and out of order, but since series numbers were used on the microfilm, reorganization at this time requires citing some series out of order. Patrons are requested to ignore series numbers on the microfilm. Old series numbers appear in parenthesis after the newly assigned number.

This record group contains the official records of Johnson County arranged in the following Subgroups: 1) Treasurer, 1865-1946; 2) Assessment Records, 1873-1975; 3) County Board of Commissioners; 4) County Clerk, 1869-1958; 5) Register of Deeds, 1859-1893; 6) County Court, 1870-1914; 7) District Court, 1954; 8) Superintendent of Schools; and 9) School District Records, 1883-1901.

Subgroup One, County Treasurer, comprises all of former Series #1 thru #4 and old Series #6 plus additional records accessioned in 1991. This subgroup is arranged into the following series: 1) Tax Lists, 1865-1884; 2) Claims Allowed and Filed, 1882-1885; 3) Apportionment of State School Funds, 1869-1875; 4) Road Fund Records,

1869-1870; 5) Motor Vehicle Tax Lists, 1935-1946; and 6) Delinquent Tax Lists, 1875-1877.

Subgroup Two, Assessment Records, 1873-1975, includes all of former Series Five on microfilm, 1873-1876, and new records accessioned in 1991 and arranged in the following series: 1) Personal & Real Property Assessment Schedules, 1873-1876 & 1930-1975; 2) Special Assessments, 1958-1975; 4) Assessors Miscellaneous Records, 1953-1975.

The State Archives has not as yet accessioned the County Board minutes or documents relating to Subgroup Three, County Board of Commissioners.

Subgroup Four, County Clerk, contains records accessioned in 1991. Included as Series One are volumes of marriage licenses and certificates, 1858-1958. These volumes (originally 52) have been taken apart and filed in folders for microfilming. They were microfilmed by the Genealogical Society of Utah in the spring of 1994 in cooperation with the Nebraska State Historical Society. An index has been done for these records by Mr. & Mrs. DeVries of Beatrice, Nebraska, volunteers for the Nebraska State Historical Society.

Series Two, Miscellaneous Records, includes a box of approximately .25 cubic feet of burial permits for the years 1927-1969, an officials' bond record dated _____, and two registers for livestock marks and brands, 1873-1934.

Subgroup Five, Register of Deeds contains four numerical indices for lots and lands in Johnson County, 1859-1891.

Subgroup Six, Court Records, includes the records of former Series Seven (1973) on microfilm and including miscellaneous loose documents appearing on reel #7. Records consist of a probate judge's docket, 1872-1874, and three justice dockets, 1870-1902.

Subgroup Seven, District Court, contains a two-volume Bill of Exception (testimony) for case #5476, Johnson County & C.B. & Q. RR Co. vs. Weber, heard on November 8, 1954. This is inventoried as SG6, Series 6. No records are in storage at the State Archives for series one thru five. The Bills of Exception were accessioned in May of 1991.

Subgroup Eight, Superintendent of Schools, consists of a single volume, Superintendents' Record, _____, accessioned in May of 1991

Subgroup Nine, School District Records, contains all of former Series Eight on microfilm, 1883-1901, inventoried as Subgroup 8, Series 1, School District #32.

The records of Subgroups One, Two and Six which are on microfilm were transferred to the State Archives October 23, 1959. Records of Subgroup Nine, School District #32, were loaned for microfilming by Mrs. Cecil Burns of Elk Creek, Nebraska, September 23, 1975. The Mark and Brand Books of Subgroup Four were transferred to

the Archives from the Nebraska Brand Recording Office, September 30, 1988. All additional material was transferred to the Archives on April 11, 1991.
