HISTORICAL NOTE

The current Department of Roads was established in 1957. It evolved from the State Board of Irrigation which was created by the Legislature in 1895 and expanded to include highways and drainage projects in 1911. The Board of Irrigation, Highways and Drainage became the Department of Public Works in 1919, the Department of Roads and Irrigation in 1933, and finally the Nebraska Department of Roads in 1957.

The department is responsible for the planning, supervision and construction of state highways and the maintenance of same.

SCOPE AND CONTENT NOTE

This collection consists of the Nebraska Department of Roads and its predecessors. Included are records of the Bureau of Irrigation, Highways and Drainage. The collection is arranged into six subgroups: 1) State Board of Irrigation, 1895-1919; 2) Bureau of Irrigation, Water Power and Drainage, 1933-1955; 3) Audit Reports, 1942-1969; 4) State Highway Commission, 1957-current; 5) Maps; 6) Geodetic Survey, Nebraska, 1932-1939, and 7) Nebraska State Safety Council

Subgroup One consists of registers for water applications, actions & claims, 1887-1922; journals & ledgers recording expenses of the board, 1895-1919.

Subgroup Two consists of miscellaneous reports and correspondence in one box a trial docket, 1896-1897, recording cases heard before the board regarding applications, an Appearance Docket, 1895-1931 and fiscal

Subgroup Three contains 123 boxes of Public Power District Contract files, 1933-1955.

Subgroup Three includes audit reports of the agency, 1942-1969.

The bulk of the records which would be included in Subgroup Four are still held by the Department of Roads. The Archives holds printed copies of reports of the state highway commission. Also, microfilm of public hearings regarding highway planning were recently copied for reference from the agency's security microfilm holdings.
